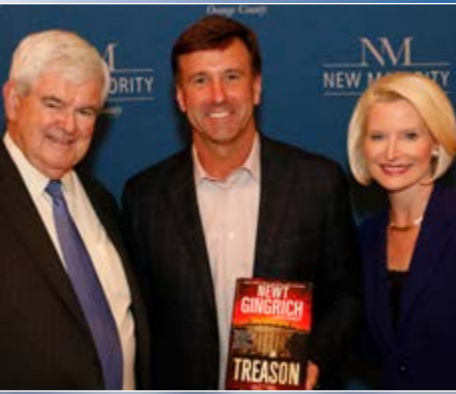
Some have fled California, but we choose to stay, and because we do, we choose to fight for better government at the federal, local and even the state level.
